## **Chief Administrative Officer's Report**

August 2016

Each monthly CAO's report provides an opportunity to provide a snapshot to Town Council, our residents and other key stakeholders of some of the key work of staff. The report shall also serve as a reporting mechanism to Town Council on specific directions given to staff through the CAO.

Very generally, the CAO is responsible for the overall operation and administration of the Town including providing leadership to senior staff and providing business, policy guidance and technical advice to Town Council, and implementing Council decisions and directives, ensuring the timely delivery of programs and services, and a fiscally responsible budget while championing the programs and policies of Council.

## **Capital Project Updates:**

### **Streets and Sidewalks**

#### **Kensington Storm Water Project**

The construction of this project has been deferred to 2017.

#### **Victoria Street West Sidewalk Replacement – Sidewalk Replacement Plan**

A funding application was submitted to the Provincial Infrastructure Fund (PIF) in July to replace a portion of sidewalk along Victoria Street West from Bell's Irving to Imperial Street. The project carried an estimated cost of approximately \$63,000, which was proposed to be funded entirely through the PIF. Funding approval was received on August 31, 2016 in the amount of \$35,000 which is insufficient to effectively complete the project. As such, staff are proposing that a new project be developed and completed within the \$35,000 approval amount. The new project being proposed is titled "Sidewalk Replacement Plan" and involves the replacement of approximately 79 concrete sidewalk pads throughout the Town. The areas proposed to be replaced are as follows:

## **Operational and Ongoing Items**

### Welcome to Kensington Signage

The “Welcome to Kensington” sign has been reinstalled along Highway 2 on property of Provincial Boat and Marine. Thank you to Provincial Boat and Marine for allowing us to utilize their property.

### Fire Department Policy Development

A draft Fire Bylaw has been finalized and will be provided to Committee of Council at their meeting scheduled for September 26, 2016. It is hoped that the Bylaw can be given first reading at the October regular meeting of Town Council. Staff continue to work with W.G. Hogan Fire Safety Specialties on specific policy development for the Fire Department.

### Annexation of 149 Kelvin Grove Road

Formal approval has been received from the Minister of Communities of the town’s application for the expansion of the Town’s boundary to include a property located at 149 Kelvin Grove Road (PID No. 465708). This process is now concluded.

### Outdoor Volleyball Courts

A rope fence has been installed between the outdoor volleyball courts and the crematorium property. This clearly delineates the property line and should keep vehicles and users of the volleyball courts from accessing the crematorium property.

### Wellfield Protection Plan

It was recommended by the Province of PEI that the Town apply to an applicable Infrastructure Fund for the development of the Wellfield Protection Plan. To date no application has been made and other opportunities to complete the project are being explored.

### 5 Year Capital Plans

Staff continue to work on the completion of a five year capital plan as time permits. Once the plans are developed in draft form they will be presented to Town Council for their consideration. It is hoped that a draft plan can be presented to Town Council for discussion at the September Committee of Council meeting. Further to this, staff are working on the consolidation of long term debt as well as specific financial related policies, Receivable Controls Policy, Debt Management Policy, Cash Flow Forecasting Policy, etc.

### Wastewater Treatment Plant Wind Turbine

The Wind Turbine is back online and has been operational since August 25<sup>th</sup>. It is apparent that the extent of the repair required was less than originally anticipated. Further information will be provided as it becomes available.

### EVK Pool

The EVK Pool was closed for the season on August 31, 2016. The 2016 season was by all accounts a successful one for the pool. Thanks to Pool Supervisor CJ Kitts and his staff for doing such a great job of operating and maintaining the pool this year.

### Kensington Area Soccer Club – Land Transfer

The Land Acquisition and Operation Agreement with the Kensington Area Soccer Club has been completed and signed by the Mayor and I. It is understood that the Agreement has been approved by the KASC Board of Directors however as of now, it has not been signed by representatives of KASC. Once signed, the KASC will be in a position to finalize their plans for the construction of their soccer clubhouse. Copies of the agreement can be viewed at the Town Hall.

### Community Gardens Complex Naming Rights Contract

A draft of the naming rights contract has been received and forwarded to the manager of the Malpeque Bay Credit Union for review. It is anticipated that the contract will be signed throughout August/September.

### Police Department False Alarm Policy

Staff continue to work on the development of a False Alarm Policy for the Kensington Police Service. It is hoped that a policy will be vetted through Committee of Council at their September meeting.

### Musical Nights at the Kensington Railyards (Tourist Activities)

We have received approval (via email) that the town's funding application to the Tourism PEI Innovation Fund. The Town has been approved for \$4,000 in funding. We are currently awaiting the formal funding contract documents.

### MIH PEI Inc. Development Permit Application

The development permit application from MIH PEI Inc. was approved at a special meeting of Town Council on July 25, 2016 subject to the provision of an entranceway permit from the Province of PEI, and the submittal of a storm water management plan for the property. All conditions were met prior to the start of construction. Construction officially started on or about the 22<sup>nd</sup> of August.

Currently staff are working on the provision of water and sewer services to the development. The Town is responsible for providing reasonable water and sewer services to the property line of the development. I have completed and submitted a project registration and assessment form to the Provincial Department of Transportation to allow the Town to bring the required services across Victoria Street East. At this point in time it appears that water services already exist to the property and a 6" sewer services will be bored under the street and into an adjacent manhole located on Victoria Street East. A quote has been requested to complete the required work.

The Mayor is the designated spokespersons for the town and communicates decisions made by Town Council. The Mayor chairs the monthly Town Council Meetings and the monthly Committee of Council meetings. All efforts are made to keep discussions and decisions transparent as we represent the town on behalf of the residents. Agenda's (along with supporting information) for Committee of Council meetings and Town Council meetings are posted on the town website on the Friday afternoon prior to the meeting. ([www.kensington.ca](http://www.kensington.ca))

Committee of Council meetings are held on the 4<sup>th</sup> Monday of each month at 6:30pm and Town Council meetings are held on the 2<sup>nd</sup> Monday of each month at 7:00pm. The agenda's (along with supporting information) are emailed to the County Line Courier, Journal Pioneer and CBC on the Friday afternoon prior to the meetings.

**Tourism** – Mr. Geoff Baker, Mr. Robert Wood and myself met with Ms. Laurel Reid who was doing a study through Central Coastal Tourism Partnership on opportunities for Tourism in the area. We were afforded the opportunity to meet with this consultant because of our commitment to tourism. This gave us an opportunity to discuss any opportunity the town or more specifically the Kensington Harvest Festival may want to consider in future plans when it comes to tourism. It was a good meeting and Ms. Reid provided valuable feedback for consideration. Thanks to the Central Coastal Tourism Partnership for providing this opportunity.

**Harvest Festival** – The 49<sup>th</sup> Kensington Harvest festival was a great success and I have heard many favorable comments on some of the changes this year. We look forward to what this committee of volunteers have to offer for 2017 as we celebrate our 50<sup>th</sup> year. Thanks to all Councillors who were able to attend events and walk in the parade. The opening ceremonies went off on schedule and a vote of appreciation to Robert Wood and staff for their dedication and commitment to making these things happen and stay on schedule. The committee members who took on the responsibility of different venues this year also deserve to be congratulated and we express our appreciation to all volunteers.

**Shriners Breakfast** – It was my pleasure to host His Honour, Lieutenant Governor, H. Frank Lewis at the Annual Shriners Breakfast during the Harvest Festival this year. His attendance was appreciated by all and especially the Shriners. Many pictures were taken and the Shriners hope to have this published in their Shriners magazine called "The Fez".



**Awards Ceremony at Fanningbank** – I was invited to attend an awards ceremony at Fanningbank by Their Honours, Lieutenant Governor H. Frank Lewis and his wife Dorothy. At this ceremony many awards were presented to worthy recipients who had provided special service or volunteerism to their community. An informal reception followed.

**Atlantic Mayors Congress** – I attended the Atlantic Mayors Congress in Truro, NS from Wednesday to Friday (September 7 – 9, 2016). Please find attached a written report on activities and issues which were addressed at the Congress.

**Report to Kensington Town Council**  
**Atlantic Mayors' Congress – September 7 – 9, 2016**  
**Truro, Nova Scotia**

It was my privilege to attend the semi-annual meeting of the Atlantic Mayors Congress in Truro, NS to be updated on issues of mutual value and to educate on other items of importance. Following is a brief summary of the proceedings. The next semi annual meeting will be held in Summerside in the spring of 2017, probably in the middle of May.

**Tour of Perennia** – This facility can best be described as an incubator facility that provides very special skills and equipment to entrepreneurs and businesses who have a desire to develop a new product, improve a manufacturing process and even manufacture products as a start up until the production levels get large enough to move to their own manufacturing facility. There are two locations in Nova Scotia (Kentville and Truro) but they work collaboratively with other provinces. The facility is designed to support the agriculture industry and works closely with the Agricultural Campus in Truro now known as Dalhousie Faculty of Agriculture and formerly known as Nova Scotia Agricultural College. It is supported with government funding but also leases out its facilities (and staff expertise) to companies wanting to solve issues or develop products. To give an example, one company is developing paint from plants and is having some success to date.

**FCM Update** – The 3<sup>rd</sup> vice president, Bill Kersten from Halifax reported the FCM has been successful in delivering the message to the federal government that Municipalities are the ones who bring the nation together and build success. He states the message has been well received in the Prime Ministers Office and the Prime Minister recognizes that Nation Building Needs Municipalities.

He reported the first round of Infrastructure funding program for Phase 1 has been announced and 304 projects have been handed out in Atlantic Canada. Nova Scotia 96, New Brunswick 51, Prince Edward Island 23 and Newfoundland and Labrador 134. The concern expressed around the table was the lack of notification and invitations to municipal leaders to these announcements. As municipalities we are also one of the contributors with the Federal Government at 50%, the Province at 25% and Municipalities at 25%. This concern is going to be brought to the attention of the respective government departments.

Phase 2 of the infrastructure program (\$48 B) is being developed now and the FCM are in consultations with the Federal Government to ensure the programs are developed to benefit municipalities. While Municipalities are diverse across the country they all share a common vision of improving quality of life for the residents and businesses.

**MP Bill Casey** - reported that the Government of Canada is very receptive to the needs of rural Canada and stated that a program is being developed to provide funding to roll out broadband coverage throughout rural Canada. This is a big undertaking but the government believes in the importance of good broadband service throughout all of Canada and not just major centers. During remarks from FCM 3<sup>rd</sup> Vice President, he also stated the government is working on this initiative.

**KPMG -Public Sector Transformation** -Bruce PeeVer discussed the need for municipalities to be able to deliver the services in this changing environment. By 2030 it is projected that 60% of the globe will live in large cities. This will have a large impact on rural communities who will see the level of revenue shrink

due to the reduction of rural taxpayers and property owners. He challenged municipal leaders to start thinking outside the box now and evaluate all the services. He offered three observations.

1. Increase revenues – user fee delivery of service and need to identify the true cost of delivering the service.
2. Decrease Expenditures – Do more with less, meaning sometimes you have to decide what services are really necessary and get out of providing some services. What are the essential services and what is the true cost of delivery? In some cases, you can continue the service but provide a lower service level. Unfortunately, he did not provide examples but I am sure if we really gave this some serious thought we could come up with our own list of possibilities.
3. New Public Sector Delivery Models – Modernize the way we pay bills, reduce payment times to suppliers and look for discounts in exchange. Look for ways to save money by having lights on when in use but off when not used, timers on heat and cooling thermostats. Alternative financing by use of public Sector financing P3. However, be sure to get professional help and advice if going this P3 route. In short, look at all your processes, modernize and automate as much as possible and you will reduce costs and delivery a better level of service. Never assume the way it is being done is the best or even needed. He gave as an example that Fredericton, NB now pay bills within 2 days of the invoice and receive discounts for doing so.

**Dr. David Gray -Dalhousie Agricultural Campus** - Three challenges face the world and they can all be addressed by Agricultural through global and strategic actions.

1. By 2050 it will be necessary to double the production of food to feed the world. This can only be done through changing farming methods and increasing yields. There is only so much land and a lot is being taken out of production for rural development.
2. Clean Water – Need to prevent contamination and reduce usage. Some food sources require a lot more water to produce than others and we may need to change our desire for some foods.
3. Climate Change – With changing of weather patterns this has both a positive and negative effect on farming. We are now able to grow some crops we could not before but it also takes some crops out of production or necessitates the need for research to develop new varieties.

Dr. Gray stated that 1 in 8 people are employed as a result of Agriculture.

**Exotic Animals** – The Atlantic Mayors Congress (AMC) in 2013 passed a resolution urging the Governments of Atlantic Canada to put in place guideline and regulations around the housing and ownership of exotic pets such as snakes, tigers, spiders, etc. Animals that are dangerous and not a local species. This resulted due to the death of the two boys in New Brunswick and the municipalities were not aware the snakes were in the town. To date no specific actions has been taken other than New Brunswick have completed a study into how this snakes was able to be brought into the country. The AMC is again debating another resolution to urge the premiers to bring this back on the agenda. It is felt the issue has lost momentum as we now have new premiers in the provinces and it may have been lost in the transfer. Municipalities do not have the authority or expertise to deal with this type of issue. The control of what comes into the country is at the borders to Canada and regulations are poor.

Looking forward to 2017 when the AMC will meet in Summerside.

## **On Stop Forced Organ Harvesting in China**

Dear Mayor Rowan Caseley

We are FalunGong practitioners from Toronto. We are here to call for help from you. We are here to urge every Canadian resident to condemn the horrific organ harvesting of Falun Gong practitioners in China and help stop the persecution and mass killing of Falun Gong practitioners. Based on all the evidence, on June 13<sup>th</sup> 2016 the U.S. House of Representatives unanimously passed Resolution 343 calling on China's communist regime to immediately stop forced organ harvesting from Falun Gong practitioners and others. We call our governments to

- E. Issue a public statement to condemn the Chinese communist regime for its persecution of Falun Gong and its atrocity of organ harvesting from Falun Gong practitioners, urging the regime to end the persecution and release all Falun Gong practitioners immediately.
- F. Urge China's government to consider fully and in timely fashion of the criminal complaints against Jiang Zemin
- G. Take active and effective measures to help stop the mass killing and organ harvesting of Falun Gong practitioners.
- H. Urge the Chinese regime to open for international inspection all detention facilities holding Falun Gong practitioners, including prisons, detention centres, and hospitals, including mental hospitals.
- I. Warning Canadians not to take the transplant tourism who may involve unknowingly complicit in the crime.

## City Resolution Sample

Whereas Falun Gong, a spiritual practice involving meditative “qigong” exercises and centered on the values of truthfulness, compassion, and tolerance, became immensely popular in the 1990s;

Whereas in July 1999, the Chinese Communist Party, particularly China former Chairman Jiang Zemin, launched an intensive, nationwide persecution designed to eradicate the spiritual practice of Falun Gong, reflecting the party’s long-standing intolerance of large independent civil society groups;

Whereas since 1999, hundreds of thousands of Falun Gong practitioners have been detained extra-legally in reeducation-through-labor camps, detention centers, and prisons, where torture and abuse are routine;

Whereas in many detention facilities and labor camps, Falun Gong prisoners of conscience comprise the majority of the population, and have been said to receive the longest sentences and the worst treatment;

Whereas in 2006, and in 2016, Canadian researchers David Matas, human rights attorney, and David Kilgour, former Canadian Secretary of State for Asia-Pacific, conducted an independent investigation into allegations of organ harvesting from Falun Gong prisoners in China, and concluded that Falun Gong practitioners being killed for their organs was highly probable;

whereas, the People’s Republic of China performs more than 10,000 organ transplantations per year and Chinese organ transplant centres advertise that matching organs can be found within 2-4 weeks, yet as of May 2013 it did not have an organized or effective public system of organ donation or distribution,

Whereas the United Nations Committee Against Torture and the Special Rapporteur on Torture have expressed concern over the allegations of organ harvesting from Falun Gong prisoners, and have called on the Government of the People’s Republic of China to increase accountability and transparency in the organ transplant system and punish those responsible for abuses; and

Whereas the killing of religious or political prisoners for the purpose of selling their organs for transplant is an egregious and intolerable violation of the fundamental right to life: Whereas China's former dictator, Jiang Zemin is responsible for all the brutal persecutions, including the evil organ harvesting.

Whereas more than 200,000 practitioners, mainly Chinese in mainland China have filed legal complaints against Jiang Zemin to China's supreme court, who is responsible for all these brutal atrocities.

Now, therefore, be it

*Resolved, That the City —*

- (1) Call on Canadian Prime Minister to request China government to stop persecuting Falun Gong and stop organ harvesting of Falun Gong whenever he meets China's leaders.
- (2) call on Federal government to urge China government to make sure that the criminal complaints against Jiang Zemin are considered fully and in timely fashion; and
- (3) condemns the practice of state-sanctioned forced organ harvesting in the People's Republic of China;
- (4) calls on the Government of the People's Republic of China and Communist Party of China to immediately end the practice of organ harvesting from all prisoners of conscience;
- (5) demands an immediate end to the 17-year persecution of the Falun Gong spiritual practice by the Government of the People's Republic of China and the Communist Party of China, and the immediate release of all Falun Gong practitioners and other prisoners of conscience;
- (6) encourages the medical community to help raise awareness of unethical organ transplant practices in China;
- (7) calls on the People's Republic of China to allow a credible, transparent, and independent investigation into organ transplant abuses; and
