  - **9.3** Motion by Councillor Gallant, seconded by Councillor Spencer to amend the General Land Use Map that is part of the Official Plan to reflect the re-zoning of 77, 79, 83 and 85 Victoria Street West from R1 to C1. Unanimously carried.
