WHEREAS the Town of Kensington Water and Pollution Control Corporation through its water and sewer utility operation, as of December 31, 2007, is in arrears to the Town of Kensington for fiscal year 2007 an amount of \$148,302.74;

**AND WHEREAS** the Town of Kensington wishes to receive the amount from the Water and Pollution Control Corporation that is now owing;

**BE IT RESOLVED** that the Town of Kensington Water and Pollution Control Corporation be empowered to borrow \$95,092.19 to repay the amount in arrears to the Town of Kensington, and \$53,210.55 to repay the line of credit for the Water & Pollution Control Corporation.
